Eligibility of Contractor:

1. Intending tenderers should produce in the form of payment certificate for completing similar type of work for at least 40% of the amount put to tender within last 3 years i.e., 2022-23, 2023-24, 2024-25 and Current Financial Year 2025-26 in a single work (Similar type of work). Credential from any Govt. /Semi Govt. and from autonomous bodies as contractor will be entertained for schemes having completion certificate as proof of credential.
2. The intending tenders if found himself eligible to participate in the tender, should download the details tender notice along with tender documents from wbtenders.gov.in the cost of tender documents and the Earnest Money Deposit (RTGS/NEFT) as specified above.
3. Eligibility criteria for participating e-tender:
4. The bidders shall have satisfactorily completed as a prime agency during the last 3 years from the date of issue of this notice at least one work of similar nature under the authority of State/Central Govt., State/Central Govt. under taking, Statutory bodies constituted under the statute of the Central/ State Govt. and having a magnitude of 40(Forty) % of the amount put tender. The completion certificate and detail communicational address of the client must be indicated in the credential certificate.
5. 3) Trade License for the Year 2025-26, P. Tax deposit challan for the year of 2025-26, PAN Card, GST Number with last GST return (GST will be applicable as per Govt. norms) and valid IT with Audited Balance Sheet for any three years consecutive / continuous (Financial Year, 2021-22, 2022-23, 2023-24 or Assessment Year, 2022-23, 2023-24, 2024-25) has to be accompanied with the technical bid document.
6. Registered Partner Ship Deed in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an behalf of company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the director of such company or the partners of such firm to upload such tender. (Non-Statutory Documents)
7. **Joint venture will not be allowed.**
8. Payment will be made as a when fund is available from the concern source. No claim whatsoever for dealing payment, if any will be entertained. Total 3 (three) nos. bill (including final bill) will be paid for this work. Contractors are requested to quote their rate accordingly.
9. No arbitration is allowed in this contract.
10. Ssecurity deposit deduct as per Govt. rule value of the work will be retained as security deposit which will be released after completion of Defect Liability Period from successful completion project. Agencies have to arrange land for direction of Plant & Machineries, storing of materials labour shed, Laboratory etc, water and electricity at their won cost and responsibility.
11. No material will be issued from the department.
12. Contractors shall have to comply with the provisos of A) the contract labour (regulation Abolition) Act. 1917 B) apprentice Act 1961& C) Minimum wages Act.1948 of the notification there of or any laws relating there to and the rules made and order issued there under from time to time.
13. The schedule of rates: as given in BOQ.
14. During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufacture/fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice. Appropriate penal action would be taken as per norms.
15. The authority reserves the right to cancel the NIT due to unavoidable circumstance and for the no claim will be entertained.
16. Bids shall remain valid for a period not less than 90 (ninety) days from the last date of submission of Financial Bid. If the bidder withdraws the bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
17. Before submission of tender, the tenderer shall have to acquaint by actual visit to the site as regards prevailing conditions and tenderer submitting tender shall be deemed to have done so. He must acquaint himself with local conditions of labour, material, transport, electricity, water, Panchayat regulations etc.
18. It will be contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No Claim whatsoever will be entertained for idle labour, establishment cost of hire & labour charges of tools & plants etc. at any circumstances.
19. The contractor shall pay of charges & fees legally payable for act out of their works & hold the employer free of such cost.

21. Contractor has to execute the work on strict supervision of the beneficiary committee & Panchayat Samiti, Engineers / Authorities.
22. Decision of Panchayat Samiti and/ or authority will be final & binding on contractor in case of any dispute.
23. Contractor should have to ensure the engagement of JOB CARD holders as unskilled workers for execution of awarded work/s. They will have to submit Annexure VI & VII as per Karmashree guideline time to time and follow the other provisos.
24. **Payment will be made after availability of Fund.**
25. **Completion of Work:** - The time of completion is generally Sl No. 1&2, 60 days for completion of work from the issuing date of work order, if not mentioned in otherwise in the work order. In case of supply work not more than 15 days will be allowed. However, the time limit will finally be mentioned in work / supply order. An amount of 0.5% on the tender amount may be deducted for each day delay by the Panchayat Samiti, Bankura-II However, after delay of such one month of the work may be cancelled. The decision of competent Executing authority of the Panchayat Samiti in this case will be final.
26. We would carry out all necessary tests of all major items at frequency spelled out in the contract document to the full satisfaction of the Engineer in Charge to achieve the best quality work at site. We will be contract bound to bring to the notice of the EIC any non-compliance of test results along with the action taken report. Submission of Civil Material Testing Report before using the same in construction work by Contractors /Agency is also mandatory if asked by the concerned Engineers
27. L1 Bidders will have to make a contract with the authority concerned with in 7(seven) days from the date of issuance of Letter of Acceptance and before issuance of Work Order; Failing which, his Earnest Money will be forfeited and blacklisting of the contractor may be initiated.
28. **ADDITIONAL PERFORMANCE SECURITY**
29. Additional Performance Security @ 10% of the tendered amount in the form of a Bank Guarantee from any Scheduled Bank shall be submitted by the successful bidder if the accepted bid value is 80% or less of the Estimate put to tender within seven working days from the date of issuance of Letter of Acceptance and before issuance of the Work Order. Failing which, his Earnest Money will be forfeited and blacklisting of the contractor may be initiated. The Bank Guarantee shall be returned immediately upon successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provision regarding deduction of security deposit from the progressive bills of the contractor as per relevant clause of the contract shall in no way be altered/affected by the provision of the Additional Performance Security.
